

RESIDENTIAL 15-YEAR LIMITED WARRANTY

Permanently installed Radianz® Quartz Surface slabs (the “Product”) are warranted by Lotte Chemical Corp. in the United States and Canada to the original owner. The Product must be fabricated and installed by an authorized Radianz® Fabricator/Installer, and used and maintained in accordance with instructions provided by Lotte Chemical Corp. . During the first fifteen (15) years after the date of initial installation, Lotte Chemical Corp. , at its option, will repair or replace without charge if the Product fails due to a manufacturing defect. Although Lotte Chemical Corp. shall make its best effort to repair or replace with the best possible color match to the original as possible, Lotte Chemical Corp. cannot guarantee that the repair or replacement will be an exact color match to the original. To obtain service under this limited warranty, you must reasonably cooperate with Lotte Chemical Corp.’s authorized service agents and provide access to the installation site. This warranty is applicable only to the original purchaser and only when the Product has been paid in full. This warranty is nontransferable and non-assignable. Any associated repair or replacement cost other than the Product will be the original purchaser’s responsibility.

This warranty excludes the following:

01. Misuse or abuse (including uneven exposure to direct sunlight, outdoor exposure and use, damage caused by impact, discoloring caused by exposure to certain chemical reagents, and damage from exposure to excessive heat);
02. The Product moved from its original place of installation;
03. Chips, cracks or any other impact damage;
(*) Crack after installation is not considered as a material defect because the product may be exposed to many potential causes of crack after installation. For example, direct heat contact, excessive weight on, or any impact damages. Also, chipping is not considered as a material defect because it might be caused by the result of scraping and bumping on especially edge of the product after installation.

05. Damage caused by exposure to excessive heat (Trivets and hot pads should always be used);
06. Damage caused by an act of nature;

14. Blemishes, such as blotches or spots, are inherent in the manufacturing process. In the event visual blemishes, blotches, or a concentration of color pigments are larger than 25mm in diameter (size of a quarter coin), the contracted fabricator should report it to the Radianz® authorized distributor prior to fabrication;
15. Natural variation within the Product (The Product pattern density may vary in color, size, shape, and distribution);
16. Any innovative use of material including, but not limited to, curving and/or bending;
17. Alteration of the Product thickness;
18. Installation of sinks;
19. Damage as a result of dry polishing or cutting;
20. Alterations to the factory finish;
21. Damages from other than manufacturing defect;
22. For the Products not paid in full;
23. Any Product installed or located outdoors, such as outdoor kitchens, BBQ work surfaces, or in heated areas such as saunas, steam rooms, and shower pans;
24. Residence not occupied by the original purchaser;
25. Other installations such as boats, recreational vehicles and flooring; and;
26. This Warranty does not cover the use of the Product for commercial purposes. “Commercial purposes” are defined as any application other than for use in a residential home interior as defined within this Residential 15-Year Limited Warranty.

This limited warranty is not transferable or assignable and only applies to the original owner of the project in the United States and Canada.

Lotte Chemical Corp., at its sole discretion, will either provide replacement product or repair defective products during the warranty period. Lotte Chemical Corp. shall have no liability for any expense, damage, or other losses, in connection with the installation of the Product.

To qualify for service under this warranty, the original owner must provide immediate notice to Lotte Chemical Corp. , no later than ten (10) days after discovery of any alleged manufacturing defect. Lotte Chemical Corp. or its service agent must be permitted to properly inspect the Product and to follow proper warranty procedures.
